COMPREHENSIVE PLAN ORDINANCE

ORDINANCE No. 8-05 TOWN OF LANARK PORTAGE COUNTY, WI

The Town Board of the Town of Lanark, Portage County, Wisconsin, do ordain as follows:

Section One: This Ordinance is entitled "Comprehensive Plan Ordinance." Pursuant to Section 62.23(2) and (3) of the Wisconsin Statutes, the Town of Lanark is authorized to prepare and adopt a Comprehensive Plan as defined in Section 66.1001(1)(a) and 66.1001(2) of the Wisconsin Statutes.

Section Two: The Plan Commission of the Town of Lanark has been working cooperatively with the assistance of the Portage County Planning and Zoning Department in preparing a Comprehensive Plan for the Town as part of a multi-jurisdictional planning effort.

Section Three: The Town Board of the Town of Lanark has adopted written procedures designed to foster public participation in every stage of the preparation of a Comprehensive Plan as required by Section 66.1001(4)(a) of the Wisconsin Statutes.

Section Four: The Plan Commission of the Town of Lanark by a majority vote of the entire Commission recorded in its official minutes, has adopted a resolution recommending to the Town Board the adoption of the document entitled "2005 Comprehensive Plan of the Town of Lanark", containing all of the elements specified in Section 66.1001(2) of the Wisconsin Statutes.

Section Five: The Town held public hearings on July 19, 2005 and July 23, 2005 regarding the proposed adoption of the Comprehensive Plan, in compliance with the requirements of Section 66.1001(4)(d) of the Wisconsin Statutes.

Section Six: The Town Board of the Town of Lanark, Portage County, Wisconsin, does, by enactment of this Ordinance, formally adopt the document entitled, "2005 Comprehensive Plan of the Town of Lanark", pursuant to Section 66.1001(4)(c) of the Wisconsin Statutes.

Section Seven: This Ordinance shall take effect upon passage by a majority vote of the members-elect of the Town Board and be posted as required by law.

Resolution to adopt the Comprehensive Plan
of the Town of Lanark, Portage County, Wisconsin

The Town Plan Commission of the Town of Lanark Resolves as Follows:

WHEREAS, Section 66.1001(1)(a) and 66.1001(2) of the Wisconsin Statutes set out the requirements for long-range Comprehensive Planning for towns, villages, and cities across the State; and

WHEREAS, Section 62.23(2) and (3) of the Wisconsin Statutes authorizes and requires the Plan Commission to prepare and recommend a Comprehensive Plan for the Town of Lanark; and

WHEREAS, The Town of Lanark opted in November 2000 to join with other Portage County communities in a multi-jurisdictional Comprehensive Planning project, and has been working cooperatively with the assistance of the Portage County Planning and Zoning Department in preparing a Comprehensive Plan for the Town of Lanark; and

WHEREAS, The Portage County Comprehensive Planning Joint Steering Committee on July 25, 2001 and the Lanark Town Board on October 15, 2001 adopted written procedures designed to foster public participation throughout the multi-jurisdictional planning project as required by Section 66.1001(4)(a) of the Wisconsin Statutes; and

WHEREAS, The Town of Lanark Plan Commission has conducted its individual planning process as part of this multi-jurisdictional project, utilized information generated as a result of County-wide Citizen Participation activities, and held officially noticed public meetings for each step of drafting the Comprehensive Plan; and

NOW, THEREFORE BE IT RESOLVED, That the Lanark Plan Commission of the Town of Lanark, Portage County, Wisconsin, by a majority vote, on this date the 16 of May, 2005 hereby adopts the document entitled "2005 COMPREHENSIVE PLAN, TOWN OF LANARK" as their Comprehensive Plan as amended and documented in the minutes of the May 16, 2005 Plan Commission meeting, containing all of the required elements specified on Section 66.1001(2) of the Wisconsin Statutes and to forward the Comprehensive Plan to the Town of Lanark Board for final approval after holding at least one required public hearing.
