ORDINANCE NO. 2009-1

An Ordinance to Adopt the Comprehensive Plan  
of the Town of Alban, Portage County, Wisconsin

The Town Board of the Town of Alban Wisconsin, do ordain as follows:

**Section 1.** Pursuant to Section 62.23(2) and (3) of the Wisconsin Statutes, the Town of Alban is authorized to prepare and adopt a Comprehensive Plan as defined in Section 66.1001(1)(a) and 66.1001(2) of the Wisconsin Statutes, and has been working with the assistance of the Portage County Planning and Zoning Department in preparing a Comprehensive Plan for the Town.

**Section 2.** The Alban Town Board has adopted written procedures designed to foster public participation during preparation of the Town's Comprehensive Plan as required by Section 66.1001(4)(a) of the Wisconsin Statutes.


**Section 3.** The Plan Commission of the Town of Alban, by majority vote of the entire Commission on September 2, 2008, as recorded in its official minutes, has adopted a resolution recommending to the Town Board the adoption of the Town of Alban Comprehensive Plan, containing all of the required elements specified in Section 66.1001(2) of the Wisconsin Statutes.


**Section 4.** The Town Board held a public hearing on the proposed Comprehensive Plan on October 7, 2008 in compliance with the requirements of Section 66.1001(4)(d) of the Wisconsin Statutes.

**Section 5.** The Town Board of the Town of Alban, Wisconsin, does, by enactment of this Ordinance, formally adopt the document entitled "Town of Alban 2008 Comprehensive Plan" pursuant to Section 66.1001(4)(c) of the Wisconsin Statutes.

**Section 6.** This Ordinance shall take effect upon passage by a majority vote of the Town Board and publication as required by law, and the Comprehensive Plan for the Town of Alban shall be amended as deemed appropriate by the Town Board.

Resolution 1-2008

Resolution to adopt the Comprehensive Plan  
of the Town of Alban, Portage County, Wisconsin

The Town Plan Commission of the Town of Alban Resolves as Follows:

**WHEREAS**, Section 66.1001(1)(a) and 66.1001(2) of the Wisconsin Statutes set out the requirements for long-range Comprehensive Planning for towns, villages, and cities across the State; and

**WHEREAS**, Section 62.23(2) and (3) of the Wisconsin Statutes authorizes and requires the Plan Commission to prepare and recommend a Comprehensive Plan for the Town of Alban; and


**WHEREAS**, The Town of Alban initially opted in November 2000 to join with other Portage County communities in a multi-jurisdictional Comprehensive Planning project, and since has been working independently with the assistance of the Portage County Planning and Zoning Department in preparing a Comprehensive Plan for the Town of Alban; and

**WHEREAS**, The Portage County Comprehensive Planning Joint Steering Committee on July 25, 2001 and the Alban Town Board on June 3, 2003 adopted written procedures designed to foster public participation throughout the multi-jurisdictional planning project as required by Section 66.1001(4)(a) of the Wisconsin Statutes; and

**WHEREAS**, The Town of Alban Plan Commission has conducted its individual planning process utilizing information generated as a result of County-wide Citizen Participation activities, and held officially noticed public meetings for each step of drafting its Comprehensive Plan; and

**NOW, THEREFORE BE IT RESOLVED**, That the Plan Commission of the Town of Alban, Portage County, Wisconsin, by a majority vote, on this date the 2nd of September, 2008 hereby adopts the document entitled "TOWN OF ALBAN 2008 COMPREHENSIVE PLAN" as their Comprehensive Plan as amended and documented in the minutes of the 5th of August, 2008 Plan Commission meeting, containing all of the required elements specified on Section 66.1001(2) of the Wisconsin Statutes and to forward the Comprehensive Plan to the Town of Alban Board for final approval after holding at least one required public hearing.
