Resolution to adopt the Comprehensive Plan
of the Town of Belmont, Portage County, Wisconsin.

The Town Plan Commission of the Town of Belmont Resolves as Follows:

WHEREAS, Section 66.1001(1)(a) and 66.1001(2) of the Wisconsin Statutes set out the requirements for long-range Comprehensive Planning for towns, villages, and cities across the State; and

WHEREAS, Section 62.23(2) and (3) of the Wisconsin Statutes authorizes and requires the Plan Commission to prepare and recommend a Comprehensive Plan for the Town of Belmont; and

WHEREAS, The Town of Belmont opted in November 2000 to join with other Portage County communities in a multi-jurisdictional Comprehensive Planning project, and has been working cooperatively with the assistance of the Portage County Planning and Zoning Department in preparing a Comprehensive Plan for the Town of Belmont; and

WHEREAS, The Portage County Comprehensive Planning Joint Steering Committee on July 25, 2001 and the Belmont Town Board on February 27, 2002 adopted written procedures designed to foster public participation throughout the multi-jurisdictional planning project as required by Section 66.1001(4)(a) of the Wisconsin Statutes; and

WHEREAS, The Town of Belmont Plan Commission has conducted its individual planning process as part of this multi-jurisdictional project, utilized information generated as a result of County-wide Citizen Participation activities, and held officially noticed public meetings for each step of drafting the Comprehensive Plan; and

NOW, THEREFORE BE IT RESOLVED, That the Belmont Plan Commission of the Town of Belmont, Portage County, Wisconsin, by a majority vote, on this date the 21st of April, 2005 hereby adopts the document entitled "2005 COMPREHENSIVE PLAN, TOWN OF BELMONT" as their Comprehensive Plan as amended and documented in the minutes of the April 21, 2005 Plan Commission meeting, containing all of the required elements specified on Section 66.1001(2) of the Wisconsin Statutes and to forward the Comprehensive Plan to the Town of Belmont Board for final approval after holding at least one required public hearing.

Ordinance No. 01-05

An Ordinance to Adopt the Comprehensive Plan of the Town of Belmont, Portage County, Wisconsin.

The Town Board of the Town of Belmont, Portage County, Wisconsin, do ordain as follows:

Section 1. Pursuant to section 62.23(2) and (3) of the Wisconsin Statutes, the Town of Belmont, is authorized to prepare and adopt a comprehensive plan as defined in section 66.1001(1)(a) and 66.1001(2) of the Wisconsin Statutes.

Section 2. The plan commission of the Town of Belmont, Wisconsin has been working cooperatively with the assistance of the Portage County Planning and Zoning Department in preparing a Comprehensive Plan for the Town as part of a multi jurisdictional planning effort.

Section 3. The Town Board of the Town of Belmont has adopted written procedures designed to foster public participation in every stage of the preparation of a comprehensive plan as required by section 66.1001(4)(a) of the Wisconsin Statutes.

Section 4. The plan commission of the Town of Belmont, by a majority vote of the entire commission recorded in its official minutes, has adopted a resolution recommending to the Town Board the adoption of the document entitled "2005 Comprehensive Plan - Town of Belmont," containing all of the elements specified in section 66.1001(2) of the Wisconsin Statutes.

Section 5. The Town held two public hearings, which took place on May 28, 2005 and June 2, 2005 regarding the proposed adoption of the Comprehensive Plan, in compliance with the requirements of section 66.1001(4)(d) of the Wisconsin Statutes.

Section 6. The Town Board of the Town of Belmont, Portage County, Wisconsin, does, by enactment of this ordinance, formally adopt the document entitled, "2005 Comprehensive Plan - Town of Belmont," pursuant to section 66.1001(4)(c) of the Wisconsin Statutes.

Section 7. This ordinance shall take effect upon passage by a majority vote of the members-elect of the Town Board and be posted as required by law.
