RESOLUTION NO. 11-07-2019

A RESOLUTION RECOMMENDING AMENDMENT OF
THE TOWN OF LANARK 2005 COMPREHENSIVE PLAN

WHEREAS, Section 66.1001(1)(a) and 66.1001(2) of the Wisconsin Statutes set out the requirements for long-range Comprehensive planning for towns, villages, and cities across the State; and

WHEREAS, Section 62.23(2) and (3) of the Wisconsin Statutes authorizes the Plan Commission to prepare, amend and recommend a Comprehensive Plan for the Town of Lanark; and

WHEREAS, the Town of Lanark Plan Commission began working cooperatively with the Portage County Planning and Zoning Department to update the Town of Lanark 2005 Comprehensive Plan in March of 2018; and

WHEREAS, the Town of Lanark Plan Commission completed a comprehensive update to the 2005 Plan which includes updates to demographic and socioeconomic information using the 2010 Decennial Census and the American Community Survey; updates to information related to transportation, utilities and community facilities, agricultural and natural resources, economic development, intergovernmental cooperation, land use, and implementation; and amendments to the Future Land Use Map of the Comprehensive Plan, as well as the Town Zoning Map; and


WHEREAS, the Town of Lanark Board held a public hearing on October 8, 2019, and after receiving a handful of suggested changes to the Future Land Use Map and Town Zoning Map, referred the suggested mapping changes back to the Town of Lanark Plan Commission for further review; the Plan Commission subsequently met November 7, 2019 and recommended the suggested mapping changes for approval; and

NOW, THEREFORE, BE IT RESOLVED, that the Plan Commission of the Town of Lanark, Portage County, Wisconsin, by a majority vote, hereby recommends adoption of the amendments to the document titled "Town of Lanark 2005 Comprehensive Plan" to the Lanark Town Board for final adoption by ordinance.





ORDINANCE NO. 11-12-2019

AN ORDINANCE ADOPTING AN AMENDMENT TO
THE TOWN OF LANARK 2005 COMPREHENSIVE PLAN

The Town Board of the Town of Lanark Ordains as Follows:

Section 1

Pursuant to Section 62.23(2) and (3) of the Wisconsin Statutes the Town of Lanark is authorized to prepare and amend a Comprehensive Plan for the Town of Lanark as defined in Section 66.1001(1)(a) and 66.1001(2) of the Wisconsin Statutes, and has been working cooperatively with the Portage County Planning and Zoning Department in amending the Town of Lanark 2005 Comprehensive Plan.

Section 2

The Plan Commission of the Town of Lanark, by a unanimous vote of the entire Commission, has adopted a resolution recommending the Town Board adopt the amended Town of Lanark 2005 Comprehensive Plan.

Section 3

The Lanark Town Board held a public hearing on the proposed amendments to the 2005 Comprehensive Plan on October 8, 2019, in compliance with the requirements of Section 66.1001(4)(d) of the Wisconsin Statutes.


Section 4

The Town Board of the Town of Lanark, Portage County, Wisconsin, does by enactment of this Ordinance, adopt the amendments to the document formerly titled "Town of Lanark 2005 Comprehensive Plan" pursuant to Section 66.1001(4)(c) of Wisconsin Statutes.


Section 5
