

# **PORTAGE COUNTY CODE OF ORDINANCES**

## **Chapter 5 CITATIONS**

### **5.1 CITATION FOR COUNTY ORDINANCE VIOLATIONS**

#### **5.1.1 CITATION ISSUANCE**

Citations may be issued for violations of the Portage County Code of Ordinances. The form of the citation shall comply with sections 23.54, 66.0113, or 345.11 of the Wisconsin State Statutes. In addition to law enforcement officers, the Portage County Planning and Zoning Director, Health Officer, and Parks Director may issue citations which are directly related to their official responsibilities. With the approval of their respective County Board legislative oversight committee, board, or commission, the designated department heads may, by written order, delegate their authority to their employees or may withdraw it. Every citation issued shall be signed with the name and title of the issuing officer.

#### **5.1.2 CASH DEPOSITS**

Cash deposits from the citations shall be paid to the Portage County Clerk of Courts who shall give receipts for said deposits.

#### **5.1.3 CASH DEPOSIT SCHEDULE**

A consolidated schedule of cash deposits for violations of this ordinance shall be maintained by the County Clerk as an appendix to this ordinance. The total forfeiture shall also include all legally applicable and mandated fees, costs, surcharges, and assessments authorized under section 66.0114(3) of the Wisconsin Statutes. The County Clerk shall be authorized to make such technical adjustments to this schedule that may be required by law from time to time.
